## A Day in CicLAvia

This month Council District 4 hosted the country's largest open streets event. CicLAvia, a tri-annual LA event closes streets to car traffic so constituents can walk, skate, bike, play and explore the iconic Wilshire Boulevard. The event covers a 6-mile radius and serves as a way to promote public health and active transportation.



This year the Bureau's very own Street Maintenance Division helped with pre-sweeping the streets and making street repairs to ensure a smooth bike ride.

Our Investigation & Enforcement Division assisted by coordinating the event with the other city agencies.

## BSS Participation in SoCal Fire

This December, the Santa Ana winds struck again causing the Creek fire in portions of Council District 7 and the shutdown of Sepulveda Blvd as a result of the Skirball fire. Bureau Staff was there to support the emergency response efforts. In partnership with Los Angeles Fire Department (LAFD) and the Emergency Operation Center (EOC), the BSS responded to the Creek Fire by opening Sunland yard to LAFD as a staging and refueling area for fire trucks and barricades.

In addition, BSS Supervisor Stephen Duprey & Superintendent Aida Valencia staffed EOC in order to coordinate the delivery of BSS resources.



## A Winter Wonderland in Council District 9

On December 13, on Central Avenue in sunny Council District 9, a Winter Wonderland was in effect. Made possible by Council Member Curren D. Price, the event featured raffles, a children's arts and crafts village, and a snow slide.



Families from all over the city showed up in sweaters and big smiles to enjoy this event. Finally, after the festivities, the event's snow was plowed out by our Street Maintenance Division.
