Wrapping Up the 2016-17 Fiscal Year

The Bureau is proud to celebrate another successful fiscal year! Amongst our accomplishments, we can include the construction of over 300,000 sq. ft. of sidewalk. In terms of Urban Forestry, we trimmed over 43,000 street trees and removed 2,000 dead trees citywide. Successful design-build projects throughout the year resulted in our Engineering Division completing over \$20 million worth of projects. In addition, the Investigation and Enforcement Division successfully improved response time and completed over 90% of inspections within three days for obstructions and illegal dumping. This fiscal year was filled with improved services, increased efficiency and innovative new projects.
